

**SCOTTIES “READY SET SCHOOL” SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. OPEN ONLY TO LEGAL RESIDENTS OF, AND CURRENTLY RESIDING WITHIN, THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA (“D.C.”) WHO ARE 18 YEARS OF AGE OR OLDER AT THE TIME OF ENTRY. VOID WHERE PROHIBITED.

1. SWEEPSTAKES PERIOD: Scotties “Ready Set School” Sweepstakes (“Sweepstakes”) begins on July 19th, 2018 at 9:00:00 a.m. Eastern Time (“ET”) and ends on September 10, 2018 at 11:59:59 p.m. ET (“Sweepstakes Period”).

2. ELIGIBILITY: The Sweepstakes is open to legal residents of and currently residing within, the 50 United States and the District of Columbia, who are 18 years of age or older at time of entry. Employees, directors, and officers, of Irving Consumer Products, Inc. Limit one (1) entry per person/household per day. A “day” is defined as commencing at 12:00:00 a.m. ET and ending at 11:59:59 p.m. ET except for the first day of the Sweepstakes Period which begins at 9:00:00 a.m. ET. Entries received from any person or email address in excess of the stated limitation will be void. All entries must be received by 11:59:59 p.m. ET on September 10, 2018 to be eligible for a prize drawing. In the event of a dispute as to who submitted an entry, the name of the “authorized account holder” associated with the email address will be deemed to be the entrant and must comply with these Official Rules. The authorized account holder is defined as the natural person who is assigned to the email address by an Internet access provider, online service provider, or other organization that is responsible for assigning email addresses or the domain associated with the submitted email address. Sponsor will not verify receipt of entries. Entries that are late, lost, stolen, undelivered, illegible, contain false information, damaged, misdirected, garbled or incomplete, altered or otherwise irregular, generated by script, macro or other automated or mechanical means, that have been submitted through illicit means or by any means which subvert the entry process or that do not conform with or satisfy any or all of the conditions set out in these Official Rules will be void. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any

automated program to enter will result in disqualification. The Website's database clock will be the official timekeeping device for the Sweepstakes.

4. DRAWINGS/ODDS: Second Prize winners: 25 Second Prize winners will be randomly selected from among all eligible entries received as of the end of each day of the Sweepstakes Period for a total of 1,400. **First Prize winners:** 3 First Prize winners will be randomly selected from among all eligible entries received as of the end of each week of the Sweepstakes Period for a total of 24 First Prize winners. For purposes of these Official Rules, each week ends at 11:59:59 p.m. ET on Monday during the Sweepstakes Period.

Grand Prize winner: 1 Grand Prize winner will be randomly selected from among all eligible entries received during the Sweepstakes Period. Non-winning entries will "roll over" to any subsequent drawing(s). The Grand Prize drawing will be conducted by the Administrator on or about September 14, 2018. Winners agree to be bound by these Official Rules and the decisions of the Sponsor and Administrator, whose decisions are final on all matters relating to this Sweepstakes. The odds of winning depend upon the number of eligible entries received as of each drawing. Limit one (1) First and one (1) Second Prize per person or household for the entire Sweepstakes.

5. WINNER NOTIFICATIONS/VERIFICATIONS: You are not a winner until your eligibility has been verified, and it is determined that you have complied with all terms of these Official Rules. Potential Grand Prize winner will be notified on or about September 14, 2018 by overnight delivery and/or telephone or email, in Sponsor's sole discretion, and must execute and return an Affidavit of Eligibility and Release of Liability/Publicity where not prohibited by applicable law, within ten (10) days of date of issuance specified in the notice. Failure to return the documents listed above within this time period, the return of a notification as undeliverable, noncompliance with these Official Rules, or Sponsor's inability to contact the potential Grand Prize winner will result in forfeiture of prize and the random selection of an alternate winner in accordance with these Official Rules. Prizes will be shipped to winners at the addresses provided at time of entry within 6-8 weeks. Sponsor is not responsible for change of mailing address. The arbitrator shall apply Massachusetts law consistent with the Federal Arbitration Act and applicable statutes of limitations, and shall honor claims of privilege recognized at law. In the event that the claimant is able to demonstrate that the costs of arbitration will be prohibitive as compared to the costs of litigation, Sponsor will pay as much of the claimant’s filing and hearing fees in connection with the arbitration as the arbitrator deems necessary to prevent the arbitration from being cost-prohibitive. If any part of this arbitration provision is deemed to be invalid, unenforceable or illegal (other than that claims will not be arbitrated on a class or representative basis), or otherwise conflicts with the rules and procedures established by JAMS, then the balance of this arbitration provision shall remain in effect and shall be construed in accordance with its terms as if the invalid, unenforceable, illegal or conflicting provision were not contained herein. If, however, the portion that is deemed invalid, unenforceable or illegal is that claims will not be arbitrated on a class or representative basis, then the entirety of this arbitration provision shall be null and void, and neither claimant nor Sponsor shall be entitled to arbitrate their dispute. Upon filing a demand for arbitration, all parties to such arbitration shall have the right of discovery, which discovery shall be completed within sixty days after the demand for arbitration is made, unless further extended by mutual agreement of the parties. **THE ARBITRATION OF DISPUTES PURSUANT TO THIS PARAGRAPH SHALL BE IN THE ENTRANT’S INDIVIDUAL CAPACITY AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE PROCEEDING. THE ARBITRATOR MAY NOT CONSOLIDATE OR JOIN THE CLAIMS OF OTHER PERSONS OR PARTIES WHO MAY BE SIMILARLY SITUATED. DO NOT ENTER THIS SWEEPSTAKES IF YOU DO NOT AGREE TO HAVE ANY CLAIM OR CONTROVERSY ARBITRATED IN ACCORDANCE WITH THESE OFFICIAL RULES.
